

# INVITING EXPRESSION OF INTEREST FROM CONSULTANTS TO WORK WITH ICAI ACCOUNTING RESEARCH FOUNDATION ON PROJECT BASED AT CHENNAI / TAMIL NADU

## 1. ABOUT THE PROJECT

- 1.1. The finance department of the Government of Tamil Nadu (GoTN) has embarked on an extensive Digital Acceleration journey to deliver robust, linear, controlled and monitored finance initiatives of the State including the implementation of the Integrated Finance and Human Resource Monitoring system (IFHRMS).
- 1.2. The implementation of new and modified systems and processes also requires the modification of the Tamil Nadu Treasury Codes, Pay and Accounts office Manual and Tamil Nadu Account Codes to ensure that these reflect the present business practices and may also necessitate the modification of statutory forms used by the State.
- 1.3. The Government and the ICAI Accounting Research Foundation are proposing to work together on this project, the key terms of reference would be as under :
  - a. Study the current regulatory framework governing Treasury and Accounts in the State of Tamil Nadu including:
    - i. Tamil Nadu Treasury Code (Volume I and II)
    - ii. Tamil Nadu Account Code (Volume I, II and III)
    - iii. Tamil Nadu Pay and Accounts Office Manual.  
and the complete functional process flow of the PAO/District Treasuries/Sub Treasuries under IFHRMS
  - b. Highlight the relevance of these codal provisions in IFHRMS
  - c. Redraft the above codes and manuals on the basis of present practices and IFHRMS with trail of all changes.
  - d. Recommend suggestions for improvement in the existing codal provisions and manuals
  - e. Review all forms used by the State and recommendations on redundancies, improvements and new forms to be documented as part of the codes and manual of the State.
